She stated that this has been an issue for years and requested the roadcrew go look at it to see if anything can be done. T. Noecker told that they could be at her house the next morning to try to figure something out.

Tofany Burk Annexation Final Plan Approval

B. Baldwin informed the supervisors that the Planning Commission unanimously agreed to recommend the Boad grant Conditional Final Plan Approval with the following conditions. Since the Planning Commission meeting, the township did receive a comment letter from the county with no significant comments. B. Baldwin, recommended that the Board grant Final Plan Approval with no conditions. J. Heim made a motion to grant Final Plan Approval with no conditions. T. Strause seconded. Voted All in Favor.

Romberger Subdivision

B. Baldwin explained that the Planning Commission agreed to recommend the Board grant Conditional Final Plan Approval with conditions. Since the Planning Commission meeting revised plans have been submitted, some

NEW BUSINESS

Hine On lot Sewage Disposal System

Dale and Susan Hine, were seeking approval to replace their onlot sewage disposal system. They would like to obtain a permit to replace their old system. However, the system absorption area is less than 100 feet from their well. The lot will not allow for the 100-foot isolation distance from the existing well. The design does keep the proposed septic tank at least 50-feet from the wells on neighboring properties, but only 80- feet from the owners well. J. Heim made a motion to approve the replacement of the onlot sewage disposal system. T. Strause seconded the motion. Voted All in Favor.

Grant Opportunities

B. Baldwin informer the Board that there is a CFA:Multimodal Transportation Fund open. This fund waives the match requirement for municipalities. If the funds are received a potential project could be the culvert replacement on Pine Creek Road. B. Baldwin provided a draft resolution that would need to be passed in order to apply. J. Heim made a motion to pass resolution 2023-3 requesting a Multimodal Transportation Fund grant of \$432,700 from the Commonwealth Financing Authority to be used for Pine Creek Road Culvert Replacement. T. Strause seconded. Voted All in Favor.
